### About the Course

#### Registration Information:

Non-members! Register now for the course and your registration includes one-year membership in CPRS. Please use the registration form on the reverse side, making note of the registration fees for CPRS or NRPA members and nonmembers. Because Institute registration is limited due to room size, registration closes when we meet capacity. A detailed package of information and the study materials are mailed three weeks prior to the actual course dates. Expect to study instructional material in detail prior to course instruction. Please do not wait to register for this course because space is limited. We recommend not to make air travel arrangements until the minimum registration numbers have been met.

**On site registration is not accepted.** *Minimum registration required per location is 40 people, maximum is 80.\** The exam for certification is recommended only to individuals who have attended a prior NPSI course. Delegates who successfully pass the NPSI exam will be certified for three years. Renewal of certification may be achieved through a re-examination process only and all renewal questions are to be addressed to NRPA, 703/858-2148. October 4-5, 2010: 8:00 a.m.-5:00 p.m. Exam October 6, 2010: 8:00 a.m.-11:00 a.m.

#### What to Know:

**Advanced reading is required, prior to the course.** This advanced reading is vital to the passing of the certification exam. The course is 15 hours of training from nationally known playground safety experts who prepare you to sit for the two hour Certified Playground Safety Inspector examination (100 questions) offered at the culmination of the certification course.

#### California Playground Regulations:

Obtaining certification from NPSI will meet the State of California requirements regarding the inspection of playgrounds by a certified playground safety inspector.

#### Clothing Tips:

The institute dress code is casual. Leave your business attire at home! Remember, meeting room temperatures vary widely, bring a light jacket. Evenings or rainy days may require cool weather clothing. Please prepare for rain and heat on day two during the playground site inspection.

#### Housing Arrangements:

Attendees are responsible for making their own hotel reservations. The hotel will confirm directly with the registrants. Rooms are not guaranteed as they are first come, first serve. Upon receiving hotel confirmation, attendees must make changes in hotel accommodations directly with the hotel. Housing is available at the Pechanga Resort Casino in Temecula. To make reservations call (888) 732-4264. Deadline for the housing discount is Friday, September 10, 2010. For the group rate let them know you are attending the MSA (Maintenance Superintendents Association) Conference. We recommend cancelling unused reservation nights within 72 hours from the date of arrival. Hotels are now charging for early checkout. Transportation to the course location is not provided. Please secure a rental car or plan for a taxi.

Temecula, CA can be accessed by Ontario International Airport (58 miles), San Diego International Airport (63 miles), and by John Wayne (Orange County) Airport (74 miles).
