REQUIREMENTS OF THE SCHOLARSHIP:

- The award is open only to professionals working directly in the field of Parks and Recreation (working a minimum of 20 hours per week).


SELECTION OF SCHOLARSHIP RECIPIENTS AND PRESENTATION OF AWARDS:


